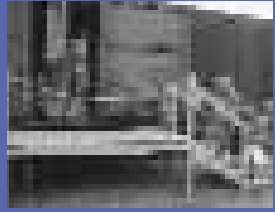

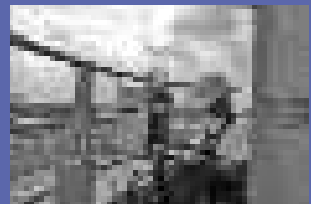

## Letter from the President



Steve Lonneman

OESI members are committed to protecting the Ohio environment. Together, they operate and maintain 11 RCRA-permitted hazardous waste management facilities in Ohio. Our members safely receive and handle about 70% of the hazardous waste managed commercially in Ohio. Hundreds of other Ohio businesses and industries rely on our RCRA facilities to provide them with safe and reliable hazardous waste management and disposal services such as waste incineration, fuel blending, resource recovery and recycling, wastewater treatment, deepwell injection, waste stabilization, land disposal, and more.

Associate OESI members provide a range of other environmental services that are also vital to the Ohio economy and environment, such as spill cleanup and remediation, training and education, emission testing, waste transportation, legal services, emergency response, public communications, and insurance.

In 2007, OESI members continued their efforts to inform and educate state and local officials about the vital role our industry plays in the Ohio industrial economy. This was especially important in 2007 because of the change in the administration to Democratic leadership. We will work throughout 2008 to continue our outreach efforts in this key area.

A priority for OESI this year will be the subject of background investigations. Each year, our members with RCRA-permitted hazardous waste facilities are required to pay up to \$5,000 for their background investigations. Other Ohio businesses and organizations where background checks are required are not financially burdened in this way; their background checks are performed by the Attorney General's Bureau of Criminal Investigations at a cost of only \$25 per person. OESI hopes to reduce the financial burden and time requirements on its members by focusing attention on this matter.

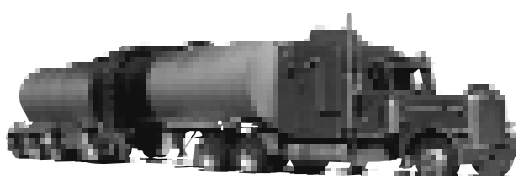

# About OESI

## Description

Ohio Environmental Service Industries (OESI) is a trade association of Ohio's commercial hazardous waste management facilities and associated businesses. Hazardous waste management members provide waste storage, treatment, disposal and recycling services; associate members provide other supporting services related to the hazardous waste industry.

OESI holds six meetings each year in Columbus or at a member facility to discuss legislative, regulatory and communication issues affecting the industry. The Association advocates before the state legislature and Ohio Environmental Protection Agency (OEPA) regarding legislation or regulations pertinent to member facilities.

## Active Members

OESI active members use state-of-the-art methods for recycling, blending, destroying or disposing of hazardous wastes. They advocate chemical recovery, reuse and recycling wherever possible, as well as sound methods for treating and disposing of hazardous wastes. ## Legislative Report for 2007

2007 was a transition year for the State of Ohio. Democrat Governor Ted Strickland and Democrat Attorney General Marc Dann were elected to their respective offices. This ended 16 years of Republican control of both the Governor's office and the Attorney General's office. The OESI Legislative Committee began its outreach to the two new office holders in 2007.

### AG Environmental Chief Addresses OESI

OESI members hosted Assistant Attorney General, Dale Vitale, to discuss the new administration, and specifically, the office's environmental background investigation unit. OESI began its dialogue with the new Attorney General's office regarding streamlining the background investigation process and information requirements. The dialogue will continue throughout 2008.

### New OEPA Director Korleski Speaks to OESI

The administration's new director of the Ohio Environmental Protection Agency, Chris Korleski, spoke to OESI members at its annual spring meeting in April 2007. Throughout the rest of the year, OESI met with other new administration personnel to discuss environmental issues.

### Lead Acid Battery Legislation Enacted

OESI members took part in the legislative debate of HB 169, which became law in 2007. This legislation created a statutory process for proper lead acid battery disposal. OESI suggested an amendment that was adopted, which allows its members to continue receiving and properly disposing of lead acid batteries as part of their business mission.

### Political/PAC Activities

Throughout 2007, members attended events to raise money for the association's political action committee, OESI-PAC. The OESI-PAC is a tool that allows the association to support legislators and statewide officials who understand the hazardous waste industry and support pro-business public policy. OESI-PAC events are held quarterly after each general membership meeting.

### Annual Statehouse Legislative Reception

OESI held its annual legislative reception for all members of the Ohio General Assembly on April 17, 2007. The reception was held jointly with the National Solid Waste Management Association. The event is important because it provides legislators and government officials the opportunity to meet OESI members, learn more about the association, and understand the critical role members have in the Ohio's economy. The annual statehouse legislative reception was very successful and was attended by nearly 60 legislators, legislative staff, and administration officials.

## OESI Facility Visits

Members of OESI hosted legislators at their facilities throughout 2007. Facility tours are a tool to better educate legislators about the nature of the hazardous waste industry and the vital role that it plays in Ohio's manufacturing economy.



## Legislative Agenda for 2008

2008 will be an election year for all the members of the Ohio House of Representatives and half the members of the Ohio Senate. The OESI Legislative Committee will continue focusing on grassroots efforts, in addition to concentrating on specific legislative efforts. Our grassroots efforts will include:

- Meeting with key members of the Ohio Senate, Ohio House of Representatives and state officials to educate them on OESI's mission and to raise awareness of the Association and our members.
- Invite local officials to tour active member facilities to demonstrate the key role each facility plays in Ohio's economy.

In 2007, OESI put together a plan to reduce state and local government regulations and restrictions on their facilities. Members decided that the cost and time involved in yearly background investigations was their number one concern and have made that their top legislative priority for 2008. Members continue to update their facilities with the best available technology while the laws and regulations remain rooted in the past. These laws and regulations have an unnecessary and costly impact on business operations, and need to be revised.

- Members of OESI are interested in modernizing the process of annual background investigations. The process required by each "key employee" takes a significant amount of time even if the employee has completed the background investigation in the past. In addition, members also believe the fees associated with the background investigations should be reduced.

## **OEPA Division of Hazardous Waste Management Retreat**

OESI plans to attend the 2008 OEPA Division of Hazardous Waste Management Retreat in the fall of 2008. The retreat gives members an opportunity to sit as a panel before OEPA Hazardous Waste Management officials and representatives from across the state and informally discuss concerns affecting the industry, as well as the agency.

## **Increase Political and PAC Activity**

Members of OESI have multiple events planned in 2008 to help raise money for the OESI-PAC. Events include dinners, an auction, and a well-attended bowling event.

## **Annual Statehouse Legislative Reception**

OESI will hold its annual legislative reception for all members of the Ohio General Assembly in April 2008, including a joint reception with the National Solid Waste Management Association. The reception helps raise awareness of Ohio's environmental service industries. The legislative reception will also provide an opportunity for members to meet their local legislators as well as members of the House and Senate Environmental Committees.

## **Regulatory Report for 2007**

The Regulatory Committee remained busy throughout 2007. Highlighted below are issues the association addressed.

### **Roundtable Meetings with OEPA, Division of Hazardous Waste**

OESI conducted quarterly Roundtable Meetings with OEPA officials to discuss regulatory and compliance issues. A formal agenda was compiled before each meeting in order to clearly identify the concerns of the members, and to help select the correct officials to invite for each discussion. These routine meetings provide both OESI and OEPA the opportunity to address regulatory concerns and issues in an informal setting.

### **Requirement for Un-manifested Wastes**

OESI members had several meetings with OEPA officials regarding un-manifested wastes reports and when they are required. OEPA representatives indicated that un-manifested waste reports should be filed by a destination facility whenever it receives non-hazardous waste that is subsequently identified as hazardous. The agency has instructed facilities to include non-hazardous waste



that is identified on a hazardous waste manifest, as well as, non-hazardous waste that is part of shipment that is accompanied by a hazardous waste manifest.

## Annual RCRA Reporting Software

In 2007, OESI members worked with OEPA Officials to make updates for the annual RCRA reporting software more efficient and effective.



## Regulatory Agenda for 2008

OESI members have prepared a list of regulatory issues to focus on in 2008, and will continue its quarterly regulatory roundtable meetings with the OEPA throughout 2008.

### Administrative Code Definitions Regarding Time Frames

Definitions for regulatory compliance terms, such as 'daily', 'weekly', 'monthly', 'quarterly', 'semi-annually' and 'annually', need to be consistent and practical for OESI members, OEPA inspectors, and permit reviewers. OESI members have proposed to the OEPA an administrative code amendment to uniformly define these time frames and improve consistency in regulatory compliance.

## Communication Report for 2007

The Communication/Education Committee continued its outreach program to inform legislators, businesses, and the public about OESI's mission, members, and hazardous waste management services. Outreach activities during 2007 are summarized below:

### Website

OESI continued to maintain its public information website, [www.oesionline.org](http://www.oesionline.org). This site features all OESI members and associate members, as well as news related to the management of hazardous wastes. The website includes links to federal and state agencies that regulate hazardous waste. OESI's annual report and membership directory are also available at the website to review or download.

## OESI Trade Show Exhibit

In March 2007, OESI participated as an exhibitor at the 16th Annual Business and Industry's Environmental, Health & Safety Symposium in Cincinnati. This symposium attracts hundreds of environmental scientists, engineers and managers from the tri-state area, and provides a valuable venue for informing them about the services OESI members provide.

In April, 2007, OESI also showcased its trade show exhibit at the annual Statehouse Legislative Reception in Columbus, Ohio, in an effort to further familiarize state legislators with the OESI organization, its members, and its mission.



## Annual Report and Membership Directory

OESI issued its fifth combined Annual Report and Membership Directory in April 2007. This report recounts the legislative, regulatory, outreach, and other activities of OESI members and committees over the year. It also includes a directory of hazardous waste management and related services provided by each member and associate member.

## Legislative Reception and Legislative Updates

In April 2007, OESI and the Ohio Chapter of the National Solid Waste Management Association co-hosted a reception for Ohio legislators at the Capital Club in Columbus. This important annual event provides an opportunity for OESI members to speak directly with legislators about their facilities and operations.

Throughout the year, OESI's executive director tracked legislative activities at the statehouse that could impact member operations, and issued updates by email to the members.

## Scholarships

A new outreach initiative was launched in February 2007 when OESI established an Annual Scholarship Fund at the University of Findlay. The fund provides four annual \$1,000 scholarships for students pursuing an undergraduate degree at the School for Environmental and Emergency Management. The first round of scholarships was awarded in August 2007 for the fall session. OESI is committed to and supports education and training for future generations of professionals seeking careers in the hazardous waste industry.

## Communication Agenda for 2008

In 2008, OESI will continue the outreach activities outlined above, including continuation of the new scholarship program for students pursuing environmental degrees.

## Membership Report for 2007

Membership remained steady in 2007 at 11 active members and 14 associate members.

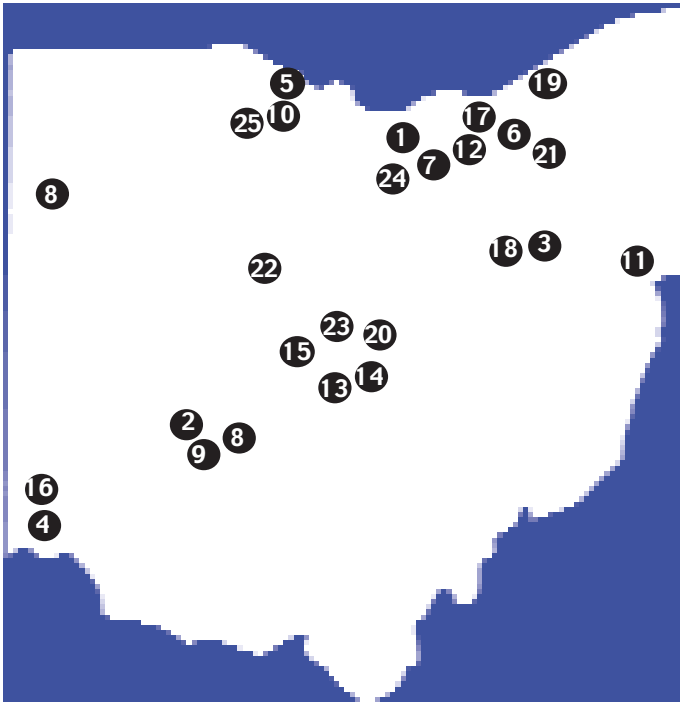
OESI provides opportunities to discuss member concerns with legislators, OEPA staff and key administrative officials. The Association also represents its members at various trade shows and symposiums each year.

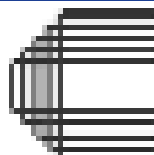
